# 1. Interpretation

1.1. Definitions: In this Agreement unless the context otherwise requires:

"Approved Account" means an account that has been verified at BlackBull Markets sole discretion. "Eligible Trades" means the trades included in clause 5.1

"Offer Duration" means until 00:00 (New Zealand Standard Time), 1st September 2022

"Free TradingView Pro Account" means a free TradingView Pro Account that would otherwise be payable subject to the conditions in this Offer.

"Offer" means this Free TradingView Pro Account promotion which is presented to you under these Terms.

"BlackBull Markets", "we" "us" or "our" means BlackBull Markets and its associated entities.
